Exhibit A Reasons for Seeking Clemency George Washington, KDOC #12345

My name is George Washington and I am 45 years old. I am currently incarcerated at Lansing Correctional Facility in the low medium-security unit. I have been incarcerated since 2010 and my release date is October 23, 2035. I am asking for clemency because (1) I have worked hard to rehabilitate myself in the past 12 years of my incarceration; (2) I have release plans to ensure I am supported and successful upon my return to the community.

I. Achievements While Incarcerated

Although I have spent almost a decade in prison, I have worked hard to make the most of my time and rehabilitate myself. I have stayed disciplinary-free since 2011, demonstrated good behavior, and remained respectful. I have always been willing to complete any available programming. While I am not considered qualified for many of KDOC's programs, I have pursued many at my own accord: I completed and earned my General Equivalency Diploma (GED) and earned numerous certifications, including my Entrepreneurs Certificate and Money Management Certificate. I have completed various other programs, including Thinking for a Change and the Brothers in Blue Reentry. I previously worked with Impact Design Inc., an outside private industry job that requires clearance to work in the community and shows the trust that the Kansas Department of Corrections has placed in me. I have also worked in the canteen, as a porter, and I am now working in custodial services. Additionally, I have stayed deeply committed to my faith. I regularly study the Bible with a group of fellow inmates on Tuesdays and Sundays as we work to rehabilitate ourselves together. My efforts to rehabilitate myself will ensure my success upon my return to the community.

II. Release Plans

My plans are to return to my daughters and my home. My sisters, brothers, nieces, and nephews have been deeply supportive and advocated for me throughout my incarceration, and they have promised to help me get back on my feet. I look forward to a quiet, peaceful life reconnecting with my family as we have all grown older and missed out on a lot of time together. I also have plans to seek treatment for my continued medical conditions as well as mental health and substance use treatment. Additionally, my GED and previous employment with Impact Design have provided me with valuable experience that will benefit my job search. My family has already contacted Graham Greene, who own Local Printing Shop, Inc., and he has stated he will give me an interview upon release. We have also identified a few other places who have hired former offenders as well. My deep family support, immediate treatment plans, and prospective employment opportunities will help me upon release.

III. Conclusion.

For the foregoing reasons, I humbly request that Governor Kelly grant me clemency so that I can safely return to the community and begin the next chapter of my life.
